

# The Schupler Chronicles Issue # 16 - October 2025



The Erie Canal becomes 200 years old on October 26, 2025. To celebrate this big birthday, let's sing!

I've got an old mule and her name is Sal,
Fifteen years on the Erie Canal.
She's a good old worker and a good old pal,
Fifteen years on the Erie Canal.
We've hauled some barges in our day,
Filled with lumber, coal, and hay,
And ev'ry inch of way I know,
From Albany to Buffalo.
Low Bridge, ev'vybody down,
Low bridge, we must be coming near a town.
You can always tell your neighbor,
You can always tell your pal if he's ever navigated on the Erie Canal.



The first shovel of dirt was dug on July 4, 1817, in Rome as the area east toward Utica and west toward Syracuse were the easiest to excavate due to the relatively flat, soft ground. Further west were the obstacles of the Montezuma Swamp and the Niagara Escarpment's limestone. To the east was more limestone plus, rapids at Little Falls and the falls at Cohoes. Construction proceeded in both directions simultaneously. The work was grueling as men shoveled mud and swung pickaxes. Black powder was used as the explosive. Injuries and illnesses such as malaria took their toll. Laborers were primarily Americans, but it has been said that the Canal's workers were Irish, and its stonemasons were German.

The Eric Canal started in controversy as people thought it impossible to dig 363 miles by hand. It was derided as "Clinton's Big Ditch" by those opposed to the Governor's vision of connecting the state from the Atlantic Ocean to the Great Lakes. Previously, General Philip Schuyler in 1792 formed the Western Inland Navigation Company which attempted to build several small locks to bypass rapids on the Mohawk River. It was a failed venture as it lacked financial resources. However, the Erie was a monumental success because of a strong work force, innovative engineering, and State loans. Small, quiet towns like Buffalo, Syracuse, and Utica turned into booming cities. Here in Herkimer County the Erie Canal was located on the south side of the Mohawk Valley running from Little Falls through Frankfort toward Utica. The Erie allowed pioneers low-cost transportation to the West. In reverse, the Erie Canal enabled westerners to ship their crops back east to markets and raw materials to factories. The prosperity that the Erie Canal created was one of the factors that enabled the North to win the Civil War. The tolls paid off the State loans in the Erie's first year of operation.

Since the Erie Canal was so successful, it was enlarged several times. The last improvement 1905-1918 was named the Barge Canal. Some of the Erie was incorporated into the Barge Canal while other parts of the Barge Canal were new excavations. Over half of the original Erie Canal was filled in and paved over by the cities and villages along its way. From the Frankfort Bridge to Dike Road, it is easy to see where the Barge Canal separated from the Mohawk River to make a straight route for barges. In the Historical Society's exhibit room, there are several old maps that show the Schuyler farms before the Barge Canal excavation separated their fields.

- All cats, dogs, and ferrets three months or older must be vaccinated, even if they stay indoors.
- Every dog and cat needs two rabies vaccinations, one year apart, then once every three years.
- Bring proof of the pet's vaccination history to receive a three year certificate.
- Ferrets must be vaccinated every year.
- Dogs should be on a leash. Cats and ferrets should be in a carrier or pillowcase.
- No vet exams will be given.
- Owners are responsible for cleaning up after their animals. Supplies are provided.
- A \$5.00 donation per pet is suggested to defray costs.

#### **Corn Festival Report by Cosmo Pellegrino:**

Cosmo Pellegrino said he began the event with \$4,550.00 on the Budget line. He said he received \$7,000.00 from donations from: \$5,000.00 Cordellio Power, \$1,000.00 from Mastrovito Hyundai, and \$1,000.00 from Hale Manufacturing, giving the 2025 event a operating budget of \$11,550.00.

On June 11, 2025 he submitted a voucher on behalf of the committee for \$6,190.00 to cover most expenses for the event leaving \$5,360.00. On the day of the event, he received income from: Car Show \$1,420.00; Vendor Fees \$1,280.00; Lottery Raffle \$338.00; Corn Qualifying \$190.00; Hot Air Balloon \$400.00. He said the only payment due is Fire Works for \$4,000.00 from the Town of Schuyler. He returned \$1,848.00 in cash to the Town Clerk,

Of the \$3,628.00, \$1,000.00 was donated to Mariah Lacey Reed Foundation. Payments were made to A & P Master Imaging in the amount of \$260.00 and CNY Awards and Apparel in the amount of \$519.00.

Cosmo Pellegrino said that with the \$1,848.00, it should leave \$3,208.00 for 2026 budget.
