# Important Survey - West Schuyler Water District



The town board was recently informed by C2AE engineering that the estimated projected cost of the West Schuyler Water District (Graham, Brown, Newport and Skyline Roads) has increased from \$4+ million to \$10+ million. Therefore, additional funding will need to be obtained. One avenue that will immediately be pursued is an income survey conducted by Jay Grasso from G&G Municipal Consulting ('G&G').

What is an income survey? An income survey is a canvassing of a specific area to determine if funding can be awarded based on income. It is a survey, and no tax information or supporting documentation will be needed.

**How does it work?** G&G will be mailing a survey to every property owner within the West Schuyler Water District. We are asking that you take a moment to complete the survey and mail it back to G&G. (these surveys do not go to the Town - they stay in the possession of G&G)

What happens if I don't complete the survey? For those who don't complete the survey, a representative of G&G will conduct a home visit to answer any questions and ask if the property owner needs any additional assistance to complete the survey. You will not be asked for any additional data after the survey.

What happens when the survey is completed? A representative from G&G will compile that data and determine the overall estimated income of property owners in the area. This number gets compared to the average income in the 13502 ZIP code area.

Why do an income survey in Schuyler? Upon conducting a preliminary review of the demographics, it was noted that there are quite a few retirees, senior citizens and non working individual within this area. Therefore, it's currently difficult to estimate a true income number that is representative of the area.

What happens if the area is found to be below the average income? The area would then become eligible for additional funding, and it will also open the project up to additional funding sources.

What happens if the area is found to be above the average income? In this scenario, additional funding will become extremely limited and the project will be cost prohibitive.

# The Schupler Chronicles

# Issue # 12 - June 2025



Tacked on the wall of the Town of Schuyler Historical Society exhibit room was a copy of an obituary from August 1944. When I read it, I knew I had to share it in this June issue of the Schuyler Chronicles. June 6, 2025, will be 81 years since the landings at the beaches of Normandy which took place on June 6, 1944, with the code name Operation Overlord. The obituary informed local residents about the death of Cpl. Stanley Sroka, a tank gunner, who was killed in action on August 28, 1944, near the village of Epernay, France. Cpl. Sroka was the son of Mr. and Mrs. John Sroka of Schuyler Corners. It states that his last letters were from France and he was extremely busy, but he was all right.

I felt that I needed to find out what happened to this local hero. Upon searching the Internet, I learned that he was attached to the 31<sup>st</sup> Tank Battalion, 7<sup>th</sup> Armored Division and "on August 28, 1944, a task force of the 7<sup>th</sup> Armored Division approached the village of Epernay, France. The village sits along the south bank of the Marne River, which they hoped to cross and then move north toward the city of Reims. They approached Epernay from the south, from Provins. The Division was outnumbered and virtually trapped and aggressively fought off the enemy. German defenders of the river crossing levied a costly toll, which also took the lives of French citizens who came to the aid of the American soldiers." (Wesley Johnston, Historian, 7<sup>th</sup> Armored Division Assn). Many of the men, including a colonel, a captain, and lieutenants, fought hard and attempted to help the badly wounded troops. One of the officers ran to a nearby town to seek help from locals in getting medical aid. It was a harrowing battle and there were many casualties, one of whom was Cpl. Sroka, who suffered traumatic injuries which resulted in his death.

According to the obituary, a memorial mass for him was celebrated at Holy Trinity Church in Utica. Cpl. Sroka is buried at the Epinal American Cemetery in Epinal,

Lorraine, France. During Cpl. Sroka's time in service, he was awarded several medals including the WWII Victory Medal, the Purple Heart, the American Campaign Medal, the Army Presidential Unit Citation, and the Army Good Conduct Medal. The American Legion Post in Herkimer, NY is named in his honor. He was 35 years old.

Ernest Hemingway once said, "Every man has two deaths: when he is buried in the ground and the last time someone says his name." I would like to think that because we mentioned Cpl. Stanley Sroka's name today that he lives on.


