The Schuyler Chronicles Issue # 17 - November 2025



If you read September's issue of The Schuyler Chronicles, then you learned about some of the daily tasks that a mother performed. This month you will read about what the fathers did 'back in the day'.

When it snowed, like in this photo in the winter of 1943, the men shoveled-and shoveled-and shoveled. (Pictured are Howard Mullholland, Martin Pentgren, and LB Budlong)





In the 1920's and 1930's, men like Ross Willis and Scott Ladd (with the help of an unnamed dog), would trap muskrat, skunk, and racoons. The pelts would be sold to help make ends meet. In 1922, skunk pelts were worth \$4.50 each; muskrat pelts were worth \$3.00 each; racoon pelts fetched \$9.00 each. By the looks of it, Mr. Willis and Mr. Ladd did pretty well for the season.

In the 1930's, the unidentified men shot this black bear in the back woods of Schuyler. They would process the meat for the family meals, then they would either make a rug for their home or sell it to a local tannery (Schuyler had two tanneries) to help support their family. In the 1920's and 30's black bear hides were worth \$20 each.





Lester Budlong and friends sawed wood with a cross-cut saw for firewood to keep the 'home fires burning' for warmth and to feed a woodstove so Mom could make some good meals for the family. Maybe some bear stew? (Picture circa 1940).

After working hard all day, these men probably met up in a cool cellar to tap a barrel of hard cider. Unlike the mom in the previous article who wanted some hard cider for 'medicinal purposes', these men drank to relax, get warm, and tell tall tales.

The Town of Schuyler Historical Society has some interesting pictures from eras gone by. Each one tells a story. You may have some of your own in your family album. Take a look at them and imagine what life was like during those time periods. Don't forget to write the names of those pictured and the date taken. It will help future generations to identify those that went before them.

- All cats, dogs, and ferrets three months or older must be vaccinated, even if they stay indoors.
- Every dog and cat needs two rabies vaccinations, one year apart, then once every three years.
- Bring proof of the pet's vaccination history to receive a three year certificate.
- Ferrets must be vaccinated every year.
- Dogs should be on a leash. Cats and ferrets should be in a carrier or pillowcase.
- No vet exams will be given.
- Owners are responsible for cleaning up after their animals. Supplies are provided.
- A \$5.00 donation per pet is suggested to defray costs.

In memory of Town Councilman Rodney Dodge

The town suffered a terrible loss on September 30th when Councilman Rodney Dodge was tragically killed in a motor vehicle accident.

Rodney was born on March 19, 1966, the son of Kenneth and Eleanor (Keyser) Dodge. He was raised locally, was a 1984 graduate of the Whitesboro Central School District and went on to pursue an associate's degree from Herkimer County Community College. On July 16, 1987, Rodney was united in marriage with Tina Countryman. Rodney worked many jobs throughout his life, most notably, his HVAC business, Dodge Home Heating & Cooling, LLC which he began in 2003.

Rodney took great pride in his community, just like his father before him, proudly serving as Town Councilman for Schuyler. He was a long-standing member of the East Herkimer Sno-Riders, where he spent countless hours volunteering. He was always on hand for the Herkimer County Fair, and if there was a truck or tractor pull going on, Rodney was your guy.



Of all his many accomplishments, nothing brought him more joy or love than his family. Rodney took the title of husband, father and grandpa ("Rot") very seriously. He was happiest spending time surrounded by family and friends. He was a loving husband, father, grandfather, brother, uncle, cousin and friend. You could always count on him to lend a helping hand. Rodney made a lasting impact on everyone that knew him and his absence will be deeply felt.

Rodney is survived by his beloved wife, Tina; his children, Lacey Dodge of Newport, Kelsey (Kyle) Rowlands of Marcy and Dale Dodge of Schuyler; his cherished grandson, Ezekiel Rowlands, who coined the name, "Rot"; brother, Ronald Dodge of Schuyler; two nephews and their families, Charles and Jennifer (Zoe, Olivia, Tyler) Dodge of Frankfort and Craig & Melissa (Jackson) Dodge of Westmoreland; his mother-in-law, Judy Countryman of Prospect and a special cousin, Diane (Bob) Zygmunt of Schuyler. He also leaves behind countless other family members who he loved dearly. He was predeceased by his parents, Kenneth and Eleanor Dodge; father-in-law, Dale Countryman and special cousins whom he thought of as his brothers, Duane, Darry and Dean Dodge.

Chairman Costanza opened the meeting at 6:00 P.M. and led the people in the Pledge of Allegiance to the Flag, along with a moment of silence for Rodney Dodge.

Motion to Approve Minutes:

Open Public Hearing – Slavic Pentecostal Church:

Public Comments:

Town Resident Donald Haman commented on the Brown-Graham-Newport Road Water District. Donald Haman's opinion is regarding bond counsel Douglas Goodfriend, had to issue his opinion, that all laws were followed before the water District could be let out for bids. For his information three sections of Town Law 12A were not lawfully followed by the Town of Schuyler Board. Section 209 F2; Section 209 F3 subsection 3, and 209F3 subsection 3, were not followed by the Town Board. Section 209F 2, Section 209F3 Subsection 3, and 209F3, subsection 5ca3, were not followed.

All of this could have been avoided when on April 6, 2022 taxpayers George Luther III and I, had made an appeal to Town Board to discuss issues with the formation of the East & West Water Districts. This appeal procedure was to review the formation of the Water Districts as stipulated in Town Law Article 12 A C-209-2091 Establishment of Improvement districts. Apparently, the Town Board did not want to discuss the Town's inability to follow Town Law as written and would not hear our appeal. The Town Board did not follow the Town Law as written in three instances. Section 209-F2 Section 3-Subsection 3 and Section 209 F 3 Subsection a,5c. My questions is, why didn't the entity empowered to enforced Town Law Address these taxpayers concerns? Who enforces Town Law and why was it not done?

Councilman Juliano asked Don Haman why would the Comptroller sign off the application? His reply was no one read the application and Town Law 209 F, which explains the rules & regulations.

Legislator Lucenti said at Herkimer County they have a new President. He said Remington has been sold. He also said the East Schuyler Water project is not dead.

Public Comments Cont'd.:

Resident Haman asked Legislator Lucenti, What was the dollar figure, that he gave to the Comptroller on his application for the aggregate assessed valuation for Water District 5?

Legislator Lucenti said that the Engineers gave the application to the Comptrollers office, not him. Mr. Haman asked him if it was C2AE? His reply was Yes.

There being no further business, motion by Juliano and second by Dodge to close the Town Board Meeting at 6:45 P.M.
