

In Memory of Town Supervisor Ron Beach



The town suffered another terrible loss with the recent passing of Town Supervisor Ronald James Beach, Jr. on November 14, 2025.

Born in Utica on January 9, 1962, he was the son of Ronald James, Sr., and Kathleen (Sullivan) Beach. Ronald was raised in Leonardsville, graduated from Mt. Markham High School and attended auctioneer school. On September 12, 1998, he married Ruby C. Bushey at Our Lady of Lourdes Church in Utica.

Ronald dedicated 35 years as a Prosthetic and Orthotic Technician at Hanger Clinic in Marcy until his retirement. A generous and compassionate man, he was grounded in his Catholic faith and tirelessly served his community. His roles included Herkimer County Legislator, Schuyler Volunteer Fire Company member, Santa's Helper for the Town of Schuyler, Boy Scout leader in Deerfield, and, most recently, served as Schuyler Town Supervisor. He was also a past member of the Leonardsville Volunteer Fire Department and actively involved in Town of Brookfield politics. For over 20 years, he supported the Kelberman Center in Utica, participating in Autism Walks and serving as auctioneer during the Boonville Autism Walk to give back to an organization that has provided vital support to his son Patrick.

Ronald's greatest source of joy was his family, especially his sons, Kyle and Patrick. They were the light of his life, and he was deeply committed to supporting them in every way possible. He was a steadfast presence at every soccer game, cross-country meet, and track meet, offering encouragement from the sidelines. He always celebrated their successes with heartfelt joy and was ever ready with thoughtful advice and a listening ear. Ronald's unwavering dedication to his family, combined with his devotion to his community, left a lasting impact on all who knew him.

We will miss Ron's selflessness, sense of humor, and dedication to the Town of Schuyler.

"Oh Christmas Tree, Oh Christmas Tree, how lovely are your branches."

For the last several years, Rick and I have had the honor of putting up and decorating the Town of Schuyler's Christmas tree in the court room of the town office. Since we are members of the town's historical society we decided to decorate the tree with vintage-style ornaments. We made some of them ourselves and purchased others. I thought it would be fun to share the pictures and instructions with you if you wanted to make some home-made ornaments for your tree. Making them is a great family and kid-friendly craft project. FYI-you'll need a glue gun and scissors.



<u>Cinnamon Sticks</u>: Hot glue two cinnamon sticks together to make an "X". Snip some greenery and berries from a Christmas pick. Hot glue them in the middle of the X. Snip a length of fabric Christmas ribbon. Put a dot of hot glue on the back of the X and press both ends of the ribbon onto the glue. Wait a few minutes for glue to cool and hang on the tree. You can also use these as gift box toppers instead of bows.



<u>Vintage Cookie Cutters</u>: I 'inherited' Mom's metal cookie cutters. Since I don't make Christmas cutout cookies anymore, I found another use for them. Once again, cut some greenery and berries from a pick and hot glue them on the metal. Cut a length of fabric Christmas ribbon and hot glue both ends on the back of the cookie cutter. You can also put a thin line any glue on the front edge of the cookie cutter then dip it in a flat plate filled with glitter. Very festive!



No-sew Fabric Ball: Head over to a store's craft department and look for the bins of Styrofoam balls then choose the size(s) you desire. Next you will need sewing fabric in a rustic or Christmas print. Measure and cut a circle of fabric large enough to fit over the ball. Make sure you have extra fabric enough to snuggly tie a length of twine or fabric Christmas ribbon into a bow and a loop at the top of the ball. Lastly, hot glue greenery with berries on to the top of the ornament.



Bright garland: We wanted to spruce up the tree (pardon the pun! LOL), so we purchased a few strands of red wooden beads at an estate sale, but you can find these in most stores with their Christmas decorations. To add a little bling, we purchased a couple of bags of metallic beads as well. With heavy string you can make a strand long enough to cover the entire Christmas tree. The red beads really brighten up the tree.

Pictured is the town Christmas tree in all its splendor. Clear lights twinkling, ornaments hung, garland strung, and a crepe paper angel watching over us.

Chairman Costanza opened the meeting at 6:00 P.M. and led the people in the Pledge of Allegiance to the Flag.

Motion to Approve Minutes:

Motion by Digristina, second by Fusillo to approve the October 1, 2025 Planning Board minutes; all in favor.

Presentation by Boulder Consultants:

Donald Ehre from Boulder Consultants and Stark Development partner John Kosak gave a presentation regarding development of a parcel in Drive-In Business Park, named Stark Development Property (Utica Roofing). Board members asked clarifying questions about the printed out plans they were given. Ehre and Kosak provided answers and further input. Chairman Costanza said they need to fill out a Planning Board application and pay the appropriate \$250.00 filing fee. Secretary Dingman printed the form for Ehre and Kosak to complete and the fee was then paid to the Town Clerk.

John Piseck from the IDA commented about some of the technical/area installations and expressed a positive outlook about what is happening in the park. He assured the board that they would provide all the information needed to proceed, as they have done in the past.

Motion to Close Meeting:

There being no additional business, a motion to close the Planning Board meeting was made at 6:33 P.M. by Digristina, second by Tripoli; all in favor.

Open Public Hearing - Acadia Energy Corp.:

A brief presentation was given by Dave Hart, Wanda Livigni, and John Bay regarding the installation of a solar farm on property owned by Bill Gaetano. Some of the points discussed included the placement of the farm, how long construction would take, and how it would benefit would the Town of Schuyler (local businesses and residents).

Chairman Mammone read a letter submitted to the Zoning Board by a bordering property owner, Timothy Riecker giving his support for this project.

The Public Hearing was concluded at 6:25 pm.

Additional Project Discussion:

Chairman Mammone also read through a letter from the Herkimer County Planning Board requiring additional information. There was a request to approve moving forward with the project, contingent on the fulfillment of the requirements from the County. The Zoning Board decided it would be in everyone's best interest to wait until those requirements are fulfilled before giving their official approval. Another meeting will be scheduled.

Note if the owner is receiving any exemptions

Providing this information promptly will allow us to complete an accurate and fair assessment. If we do not receive your response by December 1, 2025, we will be required to reassess your property using the best information available to us.
